#### **Overview:**

Mile High Youth Corps-Colorado Springs (MHYC-CS) is a regional, non-profit, AmeriCorps (<u>www.americorps.gov</u>) affiliated organization operating in Colorado Springs that provides employment, education and leadership opportunities for young adults ages 18-24. The goal of MHYC-CS is to improve life-skills, work readiness, employment prospects, and economic independence for youth, while also teaching them respect for natural resources and the outdoors. Our Corpsmembers work on conservation and environmental stewardship projects, such as fencing, noxious weed mitigation, park development, rehabilitation of sensitive riparian areas, and trail building and maintenance, on public lands in both urban and rural areas.

### **Position Description:**

The MHYC-CS Chainsaw Crew Leader positions require individuals who are skilled problem-solvers, experienced leaders and positive role models. A crew is comprised of eight to ten Corpsmembers (18-24 years old) all working together to complete conservation projects on public lands and in communities. Leaders manage a demanding work and living schedule and will be responsible for creating a valuable experience for the Corpsmembers. Leaders will be responsible for facilitating environmental education, life skills, transferable work skills, and safe, positive group living skills to their crew. Leaders must possess a strong work ethic, promote high quality work performance in their crew, and have a desire to devote themselves to field-based work and youth development for an entire summer. All positions require both supervisory and technical aptitude, in addition to a high level of comfort in the outdoors.

### **Crew Leader Duties and Responsibilities:**

- Manage, supervise, and participate in day-to-day details of crew life in camp and at work site.
- Monitor, manage, and promote crew's physical and emotional safety on and off the work site.
- Train and motivate a crew of 8-10 young adults to efficiently and safely complete conservation projects on public lands.
- Coordinate closely with the project sponsors and the Field Supervisor in order to accomplish the scope and quality of work to the sponsor's satisfaction.
- Work as a team with Crew Mentors and others to implement training curriculum that includes environmental education, leadership development, civic engagement, healthy lifestyles, career development, and service learning opportunities.
- Complete professional documentation of time sheets, daily and weekly reports, project accomplishments and other required documentation.

- Conduct Corpsmember evaluations, report incidents and corrective actions formally and in a timely manner.
- Manage petty cash, gas cards and food budget for crew.
- Transport crew safely in MHYC-CS vehicles.
- Promote individual Corpsmember development and a healthy crew community.
- Adhere to all safety rules and regulations.
- Adhere to the rules and regulations specified in the MHYC Employee and Corpsmember Handbooks.
- Implement *Leave No Trace* techniques on camp and project sites.

## **General Qualifications:**

- High School diploma or GED required. Bachelor's Degree preferred.
- Must be a **minimum of 21 years old**.
- Familiarity with the safe use of basic hand tools and chainsaws.
- Conservation, construction or landscaping experience preferred.
- Experience with youth development. Familiarity with the youth corps model preferred.
- Excellent organizational skills.
- Physically fit, able to work long days in adverse conditions.
- Ability to adhere to the MHYC-CS policy which prohibits smoking and other tobacco use in MHYC-CS facilities, vehicles or project sites.
- Current Wilderness First Aid and CPR certifications preferred. Wilderness First Responder, EMT, NOLS courses, Outward Bound courses, all a plus.
- Ability to implement MHYC-CS policies and procedures regarding disciplinary, performance, and safety requirements.
- Leadership experience with diverse young adults and a demonstrated ability to build a team.
- Desire to make a difference in the lives of Corpsmembers and communities.
- Must have reliable transportation, current driver's license and **insurable driving record**.
- Pre-employment background check and drug screen will be required. May implement drug testing throughout employment. Subject to FBI background check which involves being fingerprinted.
- Ability to legally work in the United States, which will be checked via the federal E-verify system.

## Specific Program Qualifications - Camping and Day Conservation Crews

- Experience with trail construction and maintenance, fencing, planting, rock work, light construction preferred
- Proficiency in backpacking and camping at altitude required for Camping Crews, preferred for Day Crew, preferably with leadership experience
- Chainsaw Crew leaders should have significant chainsaw experience; S-212 or MTDC with Feller Certificate; B or C feller preferred.

## **Essential Functions:**

This is *physically demanding work*! While performing the duties of this job, the employee is frequently required to walk, sit and talk or listen. The employee is required to use hands to operate tools or controls, and to reach with hands and arms. The employee is occasionally required to climb or balance, stoop, kneel, crouch or crawl. The employee must occasionally lift and/or move up to 50 pounds. Specific vision abilities required by this job include close vision and the ability to focus. The employee is frequently required to drive vehicle, and must be able to speak, understand, read and write English. The employee may be required to camp up to 10 days at a time if assigned to Camping/Saw crews.
